# **Education Director's Update**

### **Key Notes from Governors Forum**

Paul Senior - Director of Education & Inclusion shared major issues currently facing the education system nationally and locally. These include:

- The Council will continue its work of looking at school provision overall. There is 21% percent overcapacity in Hackney schools, whereas the DfE recommends a level of 5%.
- The Council will talk to Headteachers and Chairs of Governors about closures and mergers. The proposals will be discussed in cabinet in May, after which the formal process will begin.
- A joint inspection by Ofsted and the Quality Care Commission is shortly to take place. The inspectors will be visiting Hackney schools.
- The Scrutiny Committee's recent meeting focussed on exclusions. Numbers of exclusions have fallen, but the
  committee looked at the numbers of Black, Asian and Caribbean children being excluded and also noted the rise in the
  number of females being excluded. The Re-engagement Unit has increased its capacity and is now able to work with
  all schools.

- The Schools Bill has been withdrawn but some elements e.g. attendance may still be pursued. The government drive towards academisation has for the time being stopped. Hackney will continue to work towards collaborative working between schools.
- A summit is being organised in the near future to look at the vision moving towards 2030, with SEND and inclusion being particular focuses.

# Guidance on Handling Strike Action

• Following the announcement of strike action by teacher members of the National Education Union, the Department for Education (DfE) has updated its guidance on handling strike action, which explains the law on trade disputes and picketing: The guidance says that headteachers are expected to take all reasonable steps to keep the school open for as many pupils as possible. Headteachers should consult with their whole governing board before deciding whether to close, however given the urgent nature of the issue, consultation with the chair is acceptable.

## 2. Enabling achievement

## **Relevant Announcements and Reports**

The annual OFSTED report highlighted a number of national issues, not all of which will be especially relevant to Hackney. However, OFSTED may ask about them so it would be good if governors are aware of them.

- 64% of schools have not had a graded report in 5 years. 58 Hackney schools could potentially be inspected this year.
- Schools which were graded as Requires Improvement or Inadequate are more likely to improve at the next inspection.
   Schools graded as outstanding are decreasing in number as many receive a lower grading in the next inspection.
- Part time timetables are used as an alternative to exclusion. There is a danger that part time timetables could be
  misused. There has been an increase in exclusions nationally at secondary level (although an overall decrease in
  secondary exclusions in Hackney).
- There are insufficient powers to regulate unregistered schools. This has been an issue in Hackney.
- There is significant SEND weakness nationally. There are delays in accessing support.
- Some children may have been mistakenly identified as having SEND. The proposals in the green paper are addressing these issues. There has been a rise in independent special schools nationally.
- There have been difficulties in finding training places for teachers nationally. This does not appear to be an issue as
  Hackney works closely with the East London teaching hub, but governors are advised to check the position with their
  schools.

- Ofsted reported that feedback from inspection suggests that the Early Career Framework is seen as cumbersome and adding to the overall workload in schools.
- There have been no exclusions in the past few years in Hackney Primary schools. However, it is still important to be aware of the possibility of offrolling.

# 3. Assuring Provision for Pupils with SEND

SEND Strategy 2022-2025

Hackney has launched a new SEND Strategy 2022-25. We would like to thank all partners who have worked with us to produce this.

The Strategy has been co-produced with a wide range of key stakeholders across Hackney including: Families, young people, schools and settings. The overall aim of the Strategy is to provide detail on Hackney's current approach to SEND, and to set key priority areas for the coming years.

Hackney has a vision to provide an excellent, inclusive and equitable local experience for all Hackney children and young people with SEND. We want all our children and young people to have access to the right support at the right time from local services and to be able to travel easily to a great inclusive local school which engages with their neighbourhood parent/carer community. We want all our children and young people to be in schools and to access services which fairly reflect the diversity of the Hackney community.

The four main priorities in the Strategy will ensure that the above vision is progressed for our children and young people and are as follows:

- Priority One Outstanding Provision and Services
- Priority Two An Earlier Response
- Priority Three Preparing for Adulthood
- Priority Four Joining up our Services

SEND Inspection

Ofsted published its new SEND Inspection framework & handbook on 29 November 2022.

The framework outlines a new inspection model which will include full inspections, monitoring inspections, engagement meetings and area SEND thematic visits. Inspections will be unannounced and will be undertaken by Ofsted and the Care Quality Commission (CQC) inspectors who will look at:

- The experiences and outcomes of children and young people with SEND; and
- How local area partners work together to plan, evaluate and develop the SEND system.

Inspection outcomes will be published and will determine the timing and type of further inspection arrangements within the framework.

The framework sets out that inspectors will meet with children & young people, parents & carers and practitioners offsite during week 2 and onsite during week 3. This is likely to include education professionals in multi-agency tracking meetings as well as sampling visits to providers & services across education, health and care to review the experiences of Hackney resident children & young people (including those at SEN Support). During these sampling visits, inspectors may include meeting children & young people and, if appropriate, scrutinising files and talking to practitioners.

Hackney's SEND provision was last inspected in November 2017 and we, therefore, anticipate a full inspection of our arrangements across education, health and care early on in the cycle. Schools & settings will have an important role to play in the inspection and we encourage you to read the inspection framework and handbook ahead of an inspection being announced.

We will also place SEND Inspection briefings on agendas for various school based forums and meetings.

# 4. Sustainable School Systems

#### Disability Access Fund

The Disability Access Fund (DAF) can help schools make their settings accessible to children with special needs. The funding can help providers make reasonable adjustments to their settings.

Schools can use the funding, for example, to purchase specialist equipment or seek specialist training that would help meet the child's needs. Three and four year olds are eligible for DAF funding, if they meet the following criteria:

- the child receives child disability living allowance (DLA); and
- the child receives 3 and 4 year old funded early education.

Schools are responsible for identifying eligible children, and will need to obtain confirmation that the child is eligible before contacting Hackney Education Schools' Finance team to verify the child's DAF status. Any children confirmed as eligible will then need to be recorded as eligible in the January school census.
