## Roadmap for Continuing of Strategic Governance in 2020/21

The following notes, further reading references and training opportunities are provided as guidance to complement the roadmap themes and key questions, which we have updated for the Autumn term and <u>can be viewed here.</u>

# <u>Theme 1: Reopening to wider groups of children – what have been the successes and what are the challenges still to be addressed?</u>

### Risk assessments and safety procedures

- Health and Safety Executive (HSE) spot-checks: will take the form of an initial phone call to review the measures taken for reopening, to minimise spread of the virus causing COVID-19. Calls made to schools will evaluate knowledge <u>DfE Guidance for full opening School</u> (England) and the control measures required under health and safety legislation. Where there are concerns, further intervention may include a visit to the school.
- Public Health England (PHE) have published their <u>report on the preliminary</u> <u>results of the COVID-19 testing and antibody prevalence surveillance in schools programme,</u> which concludes no evidence that pupils and staff in schools were at increased risk of COVID-19
- Guidance on full opening of schools includes information about use of Face coverings
- PHE has published a series of <u>Education 'action cards' to support COVID-19 outbreak management</u> clarifying key steps to quickly identify and contain a potential Covid-19 outbreak.

DfE <u>guidance for schools on how to plan for potential local lockdowns</u> sets out four "tiers" of action that may be needed, depending on the level of
government intervention. It includes how secondary schools and colleges may
have to put in place a rota system for their pupils and in areas with the most
serious level of government intervention, school will have to switch back to only
allowing vulnerable pupils and the children of key workers on site.

## Continuity of Learning and Pastoral Support

- DfE have launched <u>Wellbeing for Education Return</u> programme. It is important that governors consider the impact of COVID-19 in strategic discussions about the assessment of physical, mental health and wellbeing of pupils throughout the school.
- The Government has published <u>Keeping Children Safe in Education</u> (KCSIE) September 2020, it replaces previous versions and this year includes a new requirement on mental health. In light of the changes to KCSIE and emerging issues as a result of lockdown, staff are being refreshed on principles in addition to guidance regarding evolving issues. This publication needs to be referenced in safeguarding policies and published on school websites.
- Checklist for school leaders on behaviour and attendance published by the
  DfE to help support schools to re-engaging their pupils from the autumn term,
  including suggestions on how to work with families to ensure all pupils attend
  and how schools ensure effective behaviour policies and practices to support
  pupils on their return.
- Attendance and Changes to School Roll: in assuring continual duty to monitor attendance and changes to school roll, governors should understand how their school is supporting attendance of all pupils and monitoring why children are removed from roll.
- Temporary changes to the school exclusion process update on changes to exclusion process confirms meetings of governing boards or independent review panels relating to exclusions between 25 September 2020 and 24 March 2021 should be held via remote access if it is not reasonably practical to meet due to COVID-19. Changes to procedural details are explained within the document.

#### Technology

- **DfE expectations for remote learning** are expected to be published soon.
- The DfE will provide more <u>laptops and tablets for disadvantaged children</u> to access remote education if local COVID-19 restrictions are required.

- <u>Returning safely to school</u>, also translated to <u>Turkish</u> and <u>Bengali</u> to share with families. Further resources available at <u>East London Health and Care Partnership</u>, DfE has also created a new <u>Back to School</u> campaign.

# <u>Theme 2: Preparations for September and beyond - planning for different</u> scenarios

- The EEF guide to supporting school planning: a tiered approach to 2020-21 - (1) high-quality teaching, (2) targeted academic support, and (3) wider strategies.
- Schools' responses to Covid-19: The challenges facing schools and pupils in September 2020 reports pupils are on average three months behind on their learning as a result of partial school closures, with deprived pupils and those from black, Asian and minority ethnic backgrounds more likely to be affected.
- Ofsted in the Autumn Term 2020 will visit around a 5% cross section of all schools, including inadequate schools (all of which can expect a visit) and a letter of the visit will be published. They will focus on what is working well and any challenges. A set of research questions are being asked which will be combined nationally, such as 'what the plans are for a blended learning model, what are the schools plans to ensure equality of access?' Inspectors will also look at: Safeguarding, Behaviour and Well-being, and where there are concerns also at Off-Rolling e.g. children being encouraged not to return once schools open and pupils exclusions.
- Early years language and speaking skills support package used to tackle the impact of lost teaching time on reception aged children and will provide language skills training and resources to children who have been worst affected at a crucial point of their development.
- NASEN have collated <u>New COVID-19 SEND Review Guide</u> for each group
  of stakeholders there are 10 statements to highlight the key areas pertinent to
  understanding and delivering effective practice for children with SEND as they
  return to school.
- Special education and the return to school study has found that roughly 20,000 pupils with SEND are unlikely to return to special schools in September, due to concerns about safety, medical vulnerability and the needs and behaviours of pupils.
- Ofqual Chair, Roger Taylor open letter addresses distress caused by the awarding of exam results

#### Theme 5: Financial management matters

- Funding schools are bearing a significant additional COVID-related costs and we await further update on whether there will be further 'Extraordinary Costs' funding.
- <u>Covid catch up premium –</u> schools will need to account for how this funding
  is being used to get back on track and ensure the curriculum has a positive
  impact on all pupils.
- **Teacher's Pay** From 1<sup>st</sup> September 2020, starting salaries for new teachers will increase by 5.5%, while the upper and lower boundaries of the pay ranges for all other teachers will increase by 2.75%. This equates to an average 3.1% increase on the collective wage bill for teachers from 1<sup>st</sup> September 2020.
- Financial Transparency: information to be published on a school's
  website. From 1st January 2021, Maintained schools, will need to publish the
  number of school employees with gross annual salary for employment at the
  school is equal to or exceeds £100,000. For Academies, this requirement
  commences from 1st September 2020
