UFSM progress and FSM Registration

Procurement framework for school catering provision



### **Universal Free School Meals**

- Funding allocated based on 22/23 census data for number of children not registered for FSM. Assumed 90% uptake therefore 90% of average number of children not registered for FSM.
- First installment (50%) was paid to schools in September.
- Second installment (25%) expected to be paid in December / January.
- Third installment (35%) expected in April 2024.
- Evaluation is being initiated shortly by the GLA and their evaluation partners. A condition of funding is to participate. Contact will be made with schools directly (likely via the Headteacher).
- The GLA deliver a webinar series to support schools which includes topics like pupil premium, implementation of UFSM. The previous webinar slides are available on the <u>GLA website UFSM</u> <u>resources page</u>. We publicise dates in the weekly Hackney Education Schools Bulletin.



## Universal Free School Meals Evidencing uptake higher than 90%

- Where a school has over 90% pupil uptake, they are able to claim for the additional funding.
- Schools will need to download data on two dates:
  - 18 January 2024 (Census day)
  - 13 March 2024 (two weeks before Easter break)
- Schools submit form to boroughs before 28 March 2024.
- Boroughs will submit this information on the GLA OPS platform.
- School can use their MIS for this. For schools who do not use MIS data, a template form will be provided for them to input their uptake data on the desired date.
- Guidance is being tested with schools and borough officers and will be available in November.



## Free School Meals and Pupil Premium

- Potential impact of the UFSM offer on FSM registration is a concern across all London boroughs
- Communications to residents promoting registration for FSM highlighting crucial funding for schools (PP) and access to additional support such as food vouchers during school holidays
- Current process
  - Once an application has been received, eligibility is re-checked weekly
  - Data highlighting children eligible and accessing FSM, not eligible, or no application made is shared with schools from the Pupil Benefits service to support schools targeted conversations with families to encourage FSM registration
- Scrutiny of data held by the Pupil Benefits service to target support to schools
- Exploring potential access to cross-reference with other Council held data sources. GDPR and usability limitations exist (often this data is owned by another Government agency e.g. DWP)



### **School Checks**

Check Synergy SAM report to identify children who have never applied for fsm to apply online – contact us if you do not have access to your schools shared SAM login

Check Synergy SAM admissions report to ensure the school roll is accurate and follow on roll off roll guidance.

Check the school transfer file (CTF) for joiners from out borough schools and record on the school system for census, you may need to contact the previous school directly. The Council pupil benefits team does not record or have access to this information.

Check no recourse to public fund families (NRPF) documentation following government advice and record on the school system for census. The Council pupil benefits team does not record or have access to this information.



### What else can be done

Publish advice and links to HE website to encourage parents to apply for FSM and school holiday lunch support on the schools website.

If a parent is unable to make an online FSM application due to language, literacy or internet device barrier then schools will shortly be able to complete a google form on the parents behalf.

Schools can inform us by email if a sibling is attending the school and the parent is unwilling to apply for the new child, in these cases we can link the children.

Pupil Benefits team will continue to access parent information from FSM application, uniform grant application and early years parent data to determine FSM eligibility and will recheck ineligible fsm application data weekly.



## **School Meals Procurement Framework**

We are developing a Catering Framework for Schools to use from September 2024.

#### Potentially 3 lots

- Lot 1 Full Inhouse Service a full catering service with meals made on with site, pre & after school
  provision if needed
- Lot 2 Partial Service meals made off site/ meals assembled on site / bento boxes
- Lot 3 In House Support support to transitioning to in house provision, Support to schools around improvising meal provision, training for staff, both teaching and catering staff around healthy meals, making meals more sustainable

Parent/ carer understanding/ access to technology	Drop ins, workshops, etc. What is the best way for your families to receive the vouchers? Team looking at developing parent/.carer friendly leaflets
If sent in post schools unaware if they've been redeemed	Team exploring ways to communicate this.
Schools/ families need a point of contact for difficulties (often during school holidays)	Team exploring who this would be/ how best this would work.
Short notice given to schools around money coming in.	Team to improve communication and share schedule.
Schools unsure of the process.	Useful weblinks. Briefing at next meeting?
