



Synergy Provider Portal and the Early Years Census


 We will be moving to a system where we open a series of three distinct 'windows' in the Provider Portal each term to allow you to claim funding and ensure you are paid the correct amount:

An **estimate** of the number of funded hours you expect to offer at the start of term (a number of hours

During the middle of the term, a new window opens to submit details of the **actual** children attending

Later in the term, a new window will open to allow you to claim for 'adjustments' (new children)

Education has to make to the DfE to make sure we
claim all the funding we need to pay settings, and
is made of your child level 'Spring term actuals'
and the annual Setting level return. So it is vital all
the children are added to the system in this
window.





Early Years Census - January 2021

Requirements

- The Early Years Census itself is unchanged for last year, the same information, but now submitted using our new Synergy Provider Portal system. There have been some Covid adjustments (next slide)
- Thursday 21st January 2021 was census day. You need to submit data on all children taking up free entitlement during census week (w/c 18 January).
- The Early Years Census contains two parts:

Part 1: Your setting level Early Years Census 2021 Form. This is 'Setting Level Data'. When you log in to the Provider Portal to submit your data, for Part 1, you will see the data you submitted last year. Please complete ASAP.

Part 2: Headcount submissions of details of children attending your setting during census week. This is 'Child Level Data', your spring term actuals. When you log in to the Provider Portal to submit your data, for Part 2, you will see the data you submitted last term, which forms the starting point for you to check, update and add to as necessary. Please complete by 19 February



Early Years Census - January 2021

Covid-19 adjustments

- Please record the expected weekly hours a child usually would have received in situations where the child is:
- self-isolating due to exposure to coronavirus (usually a period of 10 days) in census week.
- ill in census week.
- absent due to the parent/guardian choosing to care for a child at home, only if the provider remains open to the child and the parent/guardian has not altered their parental declaration relating to expected hours with the provider.
- clinically extremely vulnerable and is therefore shielding in line with government advice.
- Where the child is unable to attend due to restrictions on attendance made by the provider, the setting is considered closed to that child and therefore you shouldn't claim for funded hours



Early Years Census

Part 1 - Setting Level Form

The form is the same info as last year, submitted via the new Portal

The guidance document has details on all the info required - there is a table that can be completed by hand first so you have all the figures ready, then you can log in and update in the Portal

Or just log in and update if you are confident!

You will see your info from last year in most places - if this is incorrect, please update

Some of the info on qualifications is used for funding, so please ensure it is accurate

Two pages - click submit at the end!

It won't change immediately - needs to be processed centrally
