Running the 30 Hours Eligibility Audit Report

- Login into the Synergy Portal as usual.
- If prompted, enter your Memorable Word and click Submit.
- Select the appropriate **Term**.
- Select the appropriate Funding type.

Click on Run Reports at the top-right of the menu bar.










Running the 30 Hours Eligibility Audit Report

- When the Run Report window pops up, ignore the first (Report) drop-down list.
- Select Microsoft Excel Spreadsheet
 (Excel) from the second (Format) drop-down
 list.
- Check the box that reads Open Report after creation
- Finally, click the run report button
 The report will appear at the bottom-left of your web browser window and in most cases will appear in your default Downloads folder.
- To see any historical reports, click on the Reports tab.
- Click the **Download** button to re-download the report.

The parent/carer should re-confirm eligibility with HMRC immediately and must re-confirm eligibility before the end of this term.	2	You need to ask the parents to renew before the end date otherwise there might be a break on the child's eligibility and there is a risk of losing funding	
The Grace Period is due to expire. The child will not be eligible in the next term unless eligibility is reconfirmed before the end of this term	3	The parents must renew as soon as possible. Please encourage the parent to act promptly. There is a risk that the code might not be valid for the next term. The code will still be valid for the current academic term. N.B. the code is not valid if the child is starting at your setting during the Grace period (term)
